## PART 2 FINDINGS OF ASSESSORS

The Panel of Assessors are satisfied that the proposal adequately addresses the following criteria:

## (1) Education and Training Requirements

There is an underlying unifying theme and the modules are bonded by interactions which are either implicit or explicit. This has now been addressed and embedded in both module descriptors and assessment schedules.

**2.** Rewrite the User Interface Design module descriptor to reflect the optionality of code related instruction.

**3.** In relation to the Work Placement module, articulate a mechanism by which a learner can repeat the placement.
